

2013-14 SCRIP Rebate Program at ESCS



ESCS participates in a SCRIP program with Great Lakes Scrip, a company that facilitates rebates from retailers when we purchase gift cards through them. These rebates range from 2% - 15% of the face value of gift cards purchased, depending on the retailer.

When ESCS families make purchases through SCRIP that generates revenue for our school, HSA will rebate 50% of that revenue back to the family in the form of a discount off the following year's instructional fees. Quarterly statements will be provided to participants so they can track their spending and related profit.

Important details:

- Earning period will be from April 1, 2013 – March 31, 2014. (Includes spending between 4/1/13 and today.)
- An amount equal to 50% of the revenue generated through the participant's purchases during the earning period will be provided to the participant at the time that Instructional Fees for the 2014-15 school year are due. At that time, the participant may elect to deduct that amount from their Instructional Fee total, or donate that value to the school.
- In the case that a participant will not be enrolled in ESCS for the 2013-14 school year, the participant can elect to retain the value of their rebate one of two ways:
 1. In the form of a check from HSA, or
 2. As a donation to ESCS.
- Participants will receive quarterly statements detailing their family's SCRIP spending to date, and related revenue generated for ESCS. Statements can be expected after June 30, September 30, December 31, and March 31.
- Total rebate will not exceed Instructional Fees due. In the event that 50% of the revenue generated by a participant's spending exceeds the Instructional Fees due, ESCS will retain the difference.
